- The payment shall be made within 30 days of receiving of supplies in full at ATDC Centres and the receipt of confirmation from the Centres. The payment terms as mentioned in quote shall not be changes after placing order.

LD Clause: The Vendor will pay to the buyer penalty for the delay in delivery due to reason attribute to the seller @ 0.5% of cost of equipment overdue for each of the first four full weeks and @1% for each subsequent full weeks of delay thereafter.
